

# **DYNAMIC SPECTRUM ALLIANCE INTELLECTUAL PROPERTY RIGHTS POLICY ("POLICY")**

---

This Intellectual Property Rights ("IPR") Policy governs all activities of the Dynamic Spectrum Alliance Limited (the "DSA").

## 1.1 Definitions.

- A. "Contribution" means any material (oral or written) that is provided under circumstances that would lead a reasonable person to infer that it is intended to be included in a DSA Deliverable. A "Contributor" is any person or entity making a Contribution.
- B. "DSA Deliverable" means written work product (e.g., recommendations, procedures, policies, educational materials, reports, press releases, etc.) that are developed by DSA consistent with its Articles and under the authority of its Board of Directors (e.g., through a Work Group, Board committee, DSA staff, etc.).
- C. Other Capitalized terms, if not defined in this Policy have the meaning set forth in the Articles of Association of the DSA.

1.2 Commitments. Contributors to and participants in the development of DSA Deliverables, whether DSA Members or non-members, make commitments to license their IPR solely as set forth below.

1.3 Copyright License Grant. By making any Contribution to DSA (including but not limited to participation in the drafting of any DSA Deliverable) the contributor, its Affiliates, and its and their respective applicable licensors, are deemed to have granted and hereby grant to DSA and its licensees under all copyrights worldwide, free of charges and royalties, the perpetual, irrevocable, nonexclusive, transferable, royalty-free, paid-up, unrestricted worldwide rights to reproduce, prepare derivative works, distribute, publicly perform, and publicly display the Contribution and any derivative works thereof in any medium and without attribution or any duty to account, and to sublicense such rights.

1.4 Conditions for Contributions. No contribution may be made unless the Contributor is the exclusive copyright owner of the Contribution or has sufficient rights under copyright from the owners to make the Contribution under the terms of this Policy. The Contributors must identify all other copyright owners in the Contribution.

1.5 Ownership. All drafts of DSA Deliverables and other writings arising out of Work Group or Board activities of the DSA are owned by DSA for copyright purposes and may be licensed, sold, or given away by DSA or its designees without any duty to compensate or account to the original copyright owners. Original copyright owners retain all rights in their underlying Contributions, however, subject only to the licenses set forth in this Policy and to DSA's ownership of the final DSA Deliverables.

1.6 No Other Licenses. DSA is a trade organization and does not develop technical specifications or patentable technology. Nothing in this IPR Policy may be deemed to grant any express or implied interest in any patent or trademark, whether by implication, exhaustion, estoppel, or otherwise.
